
## Our History

The Country Music Association of Ontario (CMAOntario) is a not-for-profit organization incorporated without share capital under the Corporations Act (Ontario) on March 25, 2010. Founded in 2008, The Country Music Association of Ontario (CMAOntario) was formed with the desire to support the country music industry and our emerging artists in Ontario.

Today, our volunteer Board of Directors is comprised of a group of individuals committed to the continued growth for the Association and the community it serves.





Over the past nine years, the CMAOntario's efforts have increased the number of Ontario artists and SMEs introduced to music industry leaders, resulting in the development of new business relationships. The association has facilitated essential training and information sessions, resulting in better equipped individuals, a clearer understanding of the industry and enhanced skillsets to take advantage of business opportunities.

#### Through its programs, CMAOntario:


- educates and encourages creativity;

Overall revenues increased to \$456,855 from \$337,732, representing a 35.3% increase.






## Programs & Initiatives

In 2022, CMAOntario was able to bring the complete CMAOntario Festival & Awards weekend back to London in a fully live in–person format after two years of drive–in or cancelled events. The Association was able to uphold commitments to members and stakeholders, introduce new opportunities for Ontario artists to learn, network, and perform live in front of new audiences, re–engage with peers, and continue its objective of building new audiences – for the Festival, Conference, and associated events, participating artists, and the Association as a whole.

CMAOntario also presented four additional shows throughout the year, including a showcase at Canal Days (Port Colborne) in association with Country 89, two presentations of Country Nights in the City at Moonshine Café (Oakville) in association with In The Country with Dave Woods, and a second presentation of the Legacy Revival at Walters Music Venue (Bright).







## Legacy Revival

On Thursday, June 2nd, 2022, the **Legacy Revival** show featured Ontario's treasured pioneers at Purple Hill Country Hall in a celebration of the music that paved the way. Hosted by **Jamie Warren** and **Gary Taylor**, the event featured performances by Canadian Country Music Hall of Famer **Michelle Wright**, seven-time CCMA winner **Thomas Wade**, Juno nominated country trio **Lace**, Canadian Songwriters Hall of Famer **Robert Paquette**, and ten-time CCMA nominee **Diane Chase**.








## Songs & Stories

CMAOntario presented Songs & Stories at Toboggan Brewing on Friday, June 3. The show featured a diverse lineup of songwriters including Jason Blaine, Ryan Langdon, Dani Strong and The Wilkinsons – each of whom shared the stories behind creating their work. The evening was hosted by Randy Owen, who led the songwriters in conversation about their songs, giving the audience an opportunity to hear these creatives talk as if in their own living rooms.









## R2i TuneUp Conference

CMAOntario presented the 2022 **R2i TuneUp Conference** on Saturday, June 4th and Sunday, June 5th at the Delta London Armouries in London, Ontario. Panel discussions covered: artist development, rights management, songwriter development, music supervision, radio, breaking into the growing Quebec country market, and live performance.




CMAOntario celebrated the 10th Anniversary of the CMAOntario Awards with 20 award presentations at Centennial Hall on Sunday, June 5.



### 22 2022 AGM Minutes

Minutes of the Annual General Meeting of the Country Music Association of Ontario, held on Monday June 4, 2022, in the Gunnery Ballroom at the Delta Armouries Hotel, 325 Dundas St., London, Ontario, commencing at 12:55pm.

President Steve Kassay acted as Chair of the meeting and Holly Kassay acted as recording secretary.

- 1. Call to Order: The meeting was called to order by Steve Kassay and the agenda approved as presented.
- 2. Motion to Open the Meeting: by Patrick Duffy, seconded by Terry Ferneyhough.
- 3. Confirm Quorum: Secretary Brian Allen confirmed that quorum had not been achieved. After the expiry of the required 30-minute wait to reach quorum, the AGM was re-convened without quorum, as allowed under the Bylaws.
- 4. Opening Remarks from the President:
  Steve Kassay welcomed everyone in attendance everyone in attendance at this meeting and recognized the Board of Directors. Steve acknowledged the

retirement of Sam Arraj from the Board and thanked him for his years of dedication. Adam Clark's appointment as the new Treasurer for the Association was announced. Steve also acknowledged that Jennifer Goheen would be stepping down from the Board this year and thanked her for her service. He then proceeded to provide an overview of the Association's activities during the 2021 operations period.

- 5. Results of the Board of Directors election, conducted via a secure online platform from April 13, 2022, to April 22, 2022, were presented by Brian Allen.
  - The incumbent Directors, Steve Kassay and Michel Benac, were re-elected.
  - The CMAOntario welcomed newly elected Directors, Amber Bell and Brooke Dunford
- 6. Approval of the minutes of the July 12, 2021, AGM: On a motion by Jim Dunlop, seconded by Jamie Warren and unanimously carried, the minutes were adopted as presented.



### 24 2022 AGM I Minutes

- 7. (a) Proposal by Brian Allen to change Article 6 in the Bylaws to the following:
  - 6:1 Election of Directors
  - :1:1(a) The Country Music Association of Ontario (CMAOntario) is managed by a Board of Directors that will consist of a minimum of three (3) and a maximum of thirteen (13) Directors.
  - (b) Subject to paragraph:1:1 (e) below, a minimum of two-thirds (2/3) of the Directors shall be elected ("Elected Directors"), and the remainder may be appointed ("Appointed Directors") at the discretion of the Board provided that the total number of Appointed Directors does not exceed four (4).
  - (c) Where a Director is elected during the general elections, the Director's term shall begin at 12:00 am two (2) days after the AGM at which their election to the Board is announced and the term shall at end 11:59:59 pm one day after the AGM that falls at the end of the Director's two-year term, unless such Director resigns or is duly removed earlier than such date.

- (d) Each Director (whether elected or appointed) shall serve for a term of two years unless such Director resigns or is duly removed prior to the expiry of such two-year term. A Director may serve an unlimited number of duly elected or appointed terms.
- (e) In the event that a Director (elected or appointed) resigns or is otherwise removed prior to the completion of their two-year term and such resignation or removal results in less than two-thirds (2/3), but more than fifty percent (50%), of Directors being Elected Directors, then the minimum proportion of Elected Directors permitted shall be fifty percent (50%) until such time as general elections for Directors occur. In the event that any resignation or removal of a Director results in less than fifty percent (50%) of Directors being Elected Directors, then the Board shall, in its discretion, either: (i) elect to hold a by-election of a Director or Directors to bring the Board composition back in compliance with Section:1:1 (b) above; or (ii) elect to wait for general elections to bring the Board composition back in compliance with Section:1:1 (b) above.

Motion to accept the proposed change of Bylaw 6 via show of hands; Majority in favour; Motion passed.

Noted: Bylaw changes approved above will be effective immediately.

- 8. Steve Kassay presented a summary of The Year in Review, the Annual Report that was distributed to the members, highlighting key aspects of the report including:
  - 2021 performance results for the association including the presentation of the Association's 10th Anniversary show.
  - ii. An overview of the funding programs the Association applied to for Covid Relief, most of which were unsuccessful, with funders citing the organization did not "qualify" for the programs offered.
  - iii. Two funding applications were successful, which helped to offset the costs of proceeding with live events during the two years of the pandemic.
  - iv. Steve acknowledged and thanked the funders and sponsors for their continued financial support, as well as the dedicated team of volunteers
  - v. The Association is considering future locations for the Awards weekend and is committed to taking the event to new cities.

- 9. Financial Statements of the Association: A clean review engagement report from Prasad & Company LLP was presented by past Treasurer Sam Arraj for the fiscal year ending December 31, 2021. Sam noted that, despite the challenges presented by the pandemic, with the persistence of the team, the association was able to finish the year with a positive surplus.
  - Randy Owen requested that the year-to-year comparison (page 3 of the financial statements) include a percentage to indicate the variance from year to year.
  - KT Timmermans congratulated the organization for their efforts in 2020 and their ability to bounce back in 2021 despite the challenges they faced.

Sam asked members for recommendations on funding programs.

#### 10. Other Business/Q&A:

• A member raised the question of considering some regional workshops. Steve replied that we do consider it each year and we're also looking at the possibility of adding a series of small concerts throughout the year.

No further business was raised.
